
## 2025 NEBAT TOUR

**ALASKA: BY LAND & SEA** 

#### DAY 1: MONDAY, JUNE 9

**FAIRBANKS** 

We board our flight bound for Fairbanks, Alaska. Upon arrival we will transfer to the Springhill Suites, located in the heart of downtown Fairbanks, and check in for two nights. The evening is free for you to start exploring this riverside city!

#### DAY 2: TUESDAY, JUNE 10 (B, L)

**FAIRBANKS** 

Following breakfast, we'll depart on a guided tour of Fairbanks which includes the Gold Dredge #8 mine and the Alaska Pipeline. Learn all about the mining history of interior Alaska and try your luck at panning for gold. Then we will depart for the Sternwheeler River Boat Discovery, where we will enjoy a hearty Miner's Stew lunch before we board the boat for a narrated cruise on the Chena and Tanana Rivers. We'll stop at a recreated Athabascan village to learn about the native Alaskans' fascinating way of life.

#### DAY 3: WEDNESDAY, JUNE 11 (B, L)

DENALI PARK

Enjoy breakfast at the hotel before we travel to Denali. Upon arrival we will have lunch prior to embarking on the Tundra Wilderness Tour in Denali National Park. This 5 to 5.5-hour excursion with a certified driver-naturalist who will provide in-depth history of the park. Keep a lookout for wildlife and photo opportunities! Tonight, we'll check into the Denali Park Village Hotel for one night!

#### DAY 4: THURSDAY, JUNE 12 (B, L)

TALKEETNA

Breakfast is included at the hotel before we board our deluxe dome car for a ride on the Alaska Railroad from Denali to Talkeetna. Enjoy the spectacular views and delicious, cooked-to-order lunch on board the train. Upon arrival in Talkeetna, we will have free time to explore this iconic Alaskan town before we transfer to Anchorage and check into the hotel for one night!

#### DAY 5: FRIDAY, JUNE 13 (B, L)

**ANCHORAGE** 

We begin our day with a beautiful drive southward to the Seavey "Ididaride" Complex to learn about the family and experience a true wilderness dogsled ride! Feel the raw power, enthusiasm, and energy of the amazing Iditarod sled dogs as they pull your comfortable wheeled sled along a two-mile trek through the Alaska wilderness. Afterward, your guide will take you on a tour of the facilities and visit the kennels, where you'll be able to cuddle adorable puppies. Next, we're on our way to board Celebrity Cruises' beautiful Summit for a 7-night cruise. Get settled in your fabulous stateroom and explore the ship before we sail away at 8:00 PM.

Beginning with lunch today, all meals are included on the ship.

#### **DAY 6: SATURDAY, JUNE 14**

YAKUTAT

Get up close and personal with the gigantic Hubbard Glacier, North America's largest tidewater glacier. With 1,350 square miles of blue ice, this is the most active glacier in Alaska!

#### **DAY 7: SUNDAY, JUNE 15**

JUNEAU

Arrive: 11:30 AM, Depart: 9:00 PM

Juneau offers glacier viewing from places such as the Juneau Icefields and Glacier Bay National Park. Shore excursions offer flightseeing, tours of historic downtown, panning for gold, and more!





#### DAY 8: MONDAY, JUNE 16

Arrive: 7:00 AM, Depart: 8:00 PM

Downtown Skagway features historic false-front shops and restaurants, wooden sidewalks, locals in period costumes and restored buildings, many of which are part of the National Park Service's Klondike Gold Rush National Historic Park. There is a wide variety of shore excursions available, including a ride in an antique train car on the White Pass & Yukon Railway with views of spectacular scenery. There's something for everyone in Skagway!

#### DAY 9: TUESDAY, JUNE 17

HOONAH

Arrive: 7:00 AM, Depart: 3:00 PM

Icy Strait Point is located on Chichagoff Island, home to more brown bears than humans, where eagles soar overhead and whales are regularly seen just offshore. Experience the true Alaskan wilderness as you are surrounded by rainforest and mist-shrouded mountains. Explore a restored 1912 salmon cannery and museum, nature trails, and even a beach. Icy Strait Point is the port for adventure. Glide down the world's largest ZipRider, whale watch in the waters of Port Frederick and Point Adolphus, search for the coastal brown bears, or soar high above it all in a helicopter.

#### DAY 10: WEDNESDAY, JUNE 18

**KETCHIKAN** 

Arrive: 10:00 AM, Depart: 5:30 PM

Ketchikan is set at the southernmost entrance to Alaska's famed Inside Passage with a network of waterways that snake through some of the most spectacular wilderness in the world. It is best known for the salmon, idyllic scenery, and an incredibly rich Alaskan Native culture. From here you can visit Misty Fjords National Monument by seaplane or boat. This 2.3 million-acre park is stunning, with massive glacial cliffs and secluded bays. Other popular excursions include Totem Heritage Center, with its collection of over 30 totems dating back to the 19th century, fishing expeditions, hiking, and kayaking.

#### DAY 11: THURSDAY, JUNE 19

SCENIC CRUISING

Get ready for amazing views and wildlife like nowhere else as you sail through Alaska's Inside Passage. You'll have panoramic views of hanging glaciers, fjords, and coastal mountains. Be on the watch for whales, sea lions, seals, and a variety of water foul.

#### DAY 12: FRIDAY, JUNE 20

**VANCOUVER** 

This morning we'll disembark the ship in Vancouver, British Columbia and head to the airport for our flight home. We'll take with us wonderful memories of amazing Alaska!
